In the course of MOU both parties to the MOU mentioned above have been individually referred as "party" and jointly as "parties".




### Objective and Terms

The parties, after due consideration of various aspects have arrived at the following understanding

Ltd** and a faculty member from NKOCET will be the mentor for this project work. Continuous assessment from both the parties about the project will be carried out.
3. **NKOCET** will be the **Technical Knowledge Partner** in the technical design, development etc. activities in **Saurabh Flexipack Systems Pvt. Ltd.**
4. **NKOCET** will be a **Technical Innovation Sub-Center** for taking up collaborative research programmers to provide the industry with excellent solutions in due course of time. The basic aim of both the parties through this Sub-Centre is to produce Industry Ready Engineers in packaging industries as well as in Mechatronics Engineering domain.

5. **Saurabh Flexipack Systems Pvt. Ltd.**, will provide placement opportunity for the **NKOCET** students and groom them to become a successful engineers in Packaging industries.
